

Glass Container Recycling Charter

The Environmental Protection Department (EPD) would like to invite your organisation/company to become our Partner by signing the “**Glass Container Recycling Charter**” to jointly take part and promote glass container recycling.

Objectives

Through the participation and collaboration of different sectors under the Charter, we wish to achieve the following –

- Raise public awareness on source separation and clean recycling of waste glass containers, and drive behavioural change with a view to converting waste into resources; and
- Facilitate different sectors in the community to actively participate in glass container recycling so as to progressively achieve the overall recovery target of 50% of the amount of waste glass containers generated.

How to become our Partner

Any interested organisation/company may sign up the Charter to become our Partner committing to –

- Practising source separation and clean recycling of waste glass containers at the premises (e.g. setting up glass container recycling bins);
- Engaging the Government-appointed Glass Management Contractors (or operators of the Recycling Station of the Green@ Community¹) for free collection service of the separated waste glass containers for proper recycling and treatment; and
- Supporting the Charter and related activities.

Benefits of the Participants

Support: Government-appointed Glass Management Contractors (or operators of the Green@ Community¹) would provide free collection service of waste glass containers and the collection record.

Commendation: The Participants will be provided with a Charter certificate and a Charter sticker label for display on their premises as recognition of their commitment and effort taken in glass container recycling. The list of Partners will also be uploaded onto the EPD website for public reference.

¹ Operators of the Recycling Stations of the Green @ Community would provide free collection services for waste glass containers to residential buildings and housing estates of the following districts, including Eastern, Wanchai, Islands, Kwun Tong, Sham Shui Po, Wong Tai Sin, Kwai Tsing, Sha Tin, Tai Po, Yuen Long, Tuen Mun and Sai Kung. The collected waste glass containers would then be transferred to the EPD-appointed GMCs for further processing.
