引言

INTRODUCTION

學 生 資 助 辦 事 處 致 力 於 使 用 符 合 環 保 的 方 式 以 改 善 工 作 環 境 及 提 供 公 共 服 務 。

我們的理想是協助所有符合資格 及需要經濟援助的學生達到心間 中的教育水平,以及獎賞和鼓勵學 業成績優異的學生。在 2009/10 學 年, 我們就各項計劃共收到約 810 000 份申請及為約 560 000 名 在經濟上有需要的學生安排發放 一筆過支援津貼。

儘管本辦事處需要處理大量申請,我們仍然積極推行各種環保措施以減少廢物、節約能源、提倡「循環再用」資源,以及提高員工的環保意識。

本報告概述學生資助辦事處於 2009 年所採取的環保措施及成效,以及期望於 2010 年達到的目標。 The Student Financial Assistance Agency (SFAA) is committed to improving its working environment and providing public services in an environmentally responsible manner.

Our vision is to assist qualified students in need of financial assistance to achieve the education level they aspire to, and to reward and encourage students who have excelled in their studies. In the 2009/10 academic year, we have received around 810 000 under various applications financial assistance schemes and have arranged the one-off support grant for around 560 000 needy students.

Despite the large number of applications processed by SFAA, we act consciously in the implementation of green measures for minimising waste, conserving energy, promoting recycling of resources and arousing staff awareness in environmental conservation.

This report aims to cover the green measures adopted by SFAA, our achievements in 2009 and the objectives that we set for 2010.



由於本處的日常運作主要是在辦公室內進行,我們主要的環保措施包括:1)節約用紙;2)節約能源;3)資源回收及循環再用;及 4)減少污染及營造一個綠化的工作環境。我們亦會不時提醒員工善用資源,減少製造廢物。

我們致力推行下列的環保措施,以 改善我們的環境:

1) <u>節約用紙</u>

- 定期再次傳閱有關節約用紙的 通告,以提倡員工盡量減少用 紙;
- > 減少影印和避免印製過量複本;
- 使用雙面影印或列印;
- 增加使用電郵通訊,以代替便 箋;
- 將電郵通訊推及至更多員工;
- 將分享使用的資料放在部門電子報告板上,以取代複製影印本給使用者:
- 利用已使用的紙張空白的一面 作接收傳真、草擬及影印等用 途:

Since this Agency operates under an office type environment, the major environmental measures are confined to 1) Economisation of Paper Consumption; 2) Energy Saving; 3) Reuse and Recycling of Resources; and 4) Minimisation of Pollution and Establishment of a Green Workplace. Staff members are regularly reminded to economise the use of resources and reduce waste production.

We are committed to improving our environment by adopting the following measures:

1) Economisation of Paper Consumption

- Promoting the message of economisation of paper consumption by regular re-issue of circulars to all SFAA staff;
- Minimising photocopies and avoiding producing excessive copies;
- Practising double-sided photocopying or printing;
- Maximising the use of electronic mails instead of memos in hardcopies;
- Extending the use of emails to more staff;
- Posting share-use materials on the Agency's internal bulletin board instead of making hardcopies to individual users;
- Using the blank side of used paper for receiving fax, drafting or photocopying;



- 循環使用舊信封及檔案封套:
- 傳真文件時,避免使用傳真蓋 頁;
- 將電子處理假期申請系統的使用推廣至更多合約員工;
- ▶ 發送電子節日賀卡:
- ▶ 使用部門電子電話簿,代替印刷本。

2) 節約能源

- 關掉無人使用的電燈或電器;
- 張貼有關"節約能源"的告示及標籤於當眼處以提醒員工:
- 使用更具能源效益的照明燈及電器;
- 使用百葉簾以調節射進室內的 陽光強度,以配合不同季節的 需要:
- 如發現"冷點",立即要求保養維修人員檢查及調節有關設備;
- 經常保持空調房間的門關閉;

- Reusing envelopes and loose minute jackets;
- Avoiding the use of fax cover sheets;
- Extending the e-leave system to more contract staff:
- Sending electronic seasonal greeting cards:
- Replacing the Agency's internal hardcopy telephone list with an electronic list.

2) Energy Saving

- Switching off lights or electronic appliances when not in use;
- Affixing 'saving energy' notices and stickers on prominent places to remind staff;
- Using "energy-efficient" lighting and appliances;
- Using venetian blinds to adjust the penetration of sunlight to suit different seasons:
- Requesting maintenance staff to check and adjust the air-conditioning system if "cold spots" are located;
- Always keeping the doors of air-conditioned rooms closed;



- 鼓勵員工在可行的情況下,應 盡量使用樓梯代替升降機上落 樓層;
- 除需要長時間加班工作,否則 辦公時間以外一律停止空調及 照明系統:
- 於飲水機及影印機安裝時間掣並設定於非辦公時間內關掉電源以節省能源;
- 為辦公室設備設定在辦公時間 內暫停使用時進入「睡眠模式」;
- 購買並使用貼有能源效益標籤的電器用品。

- Encouraging staff to use staircases instead of lifts, if possible;
- Except for zones having prolonged overtime work, provision of air-conditioning and lighting will stop after office hours;
- Providing water dispensers and photocopiers with timers to switch power off during non-office hours for energy saving;
- Setting 'sleep mode' in office equipment when not in use during office hours;
- Procuring and using electric appliances affixed with the Energy Efficiency Labels.

3) 資源回收及循環再用

- ▶ 回收可供循環再造的紙張:
- ▶ 回收已用完的打印機或傳真機 碳粉盒:
- 於採購物料及辦公室文具時, 會盡量選購符合環保的產品, 如再造紙等:
- 設置環保回收箱收集可再用的 信封及紙張;
- ▶ 循環使用節日裝飾品。

3) Reuse and Recycle of Resources

- Collecting waste paper for recycling;
- Collecting used toner cartridges of printers and fax machines for recycling;
- Choosing green products in procuring stores and office stationery such as recycled paper, etc. as far as practicable;
- Putting up green boxes to collect reusable envelopes and papers;
- Reusing decorative accessories for festival decorations.



4) <u>減少污染及營造一個綠化的工</u> 作環境

- 支持『清新空氣約章』,如車輛在一段時間內無需運作時,會把汽車引擎關掉,並善用天然光線:
- 執行無煙工作間及保持環境清潔;
- 栽種更多盆栽 , 美化工作環境;
- 安排部門車輛一次過接載工作 地點相近的外勤員工;
- 鼓勵外勤員工使用公共交通工具;
- ➢ 部門車輛使用無鉛汽油;
- 加強同事環保意識,鼓勵他們 參與環保活動及培訓。

Minimisation of Pollution and Establishment of a Green Workplace

- Supporting the "Clean Air Charter", such as switching off the engine of vehicles when they are left idle for a considerably long time, and maximising the use of daylight;
- Maintaining a smoke-free and clean workplace;
- Increasing the number of potted plants to beautify our working environment;
- Scheduling the same departmental car trip for users whose destinations are close to one another;
- Encouraging officers to use public transport when performing outside duties;
- Using unleaded petrol for the departmental car;
- Promoting staff awareness and participation in activities and training on green management.



二〇〇九年的工作成效 ACHIEVEMENTS IN 2009

本處於 2009 年推行的環保措施,取得以下成效:

1) 節約用紙

- 員工已習慣透過電郵或部門電子告示板查閱通告及電話簿等,省卻複製影印本的紙張:
- 員工利用已使用的紙張空白的 一面作接收傳真、草擬及影印等 用途;
- 將部門出版的刊物上載於本處網頁,減少了刊物的印行數量;
- 2009 年的電郵使用者數量比 2008 年增加了 6%,約 98%員 工可透過使用電子工具作內部 相互之溝通:
- 2009 年使用電子處理假期申請 系統的合約員工比 2008 年增加 了 2%。

With the implementation of our green measures, we have made the following achievements in 2009:

1) Economisation of Paper Consumption

- Staff are used to check circulars and the internal telephone list through email or internal bulletin board and hence reducing the need for photocopies;
- Staff are using the blank side of used paper for receiving fax, drafting or photocopying;
- Departmental publications were uploaded onto the homepage of SFAA and the number of printed copies was reduced;
- The number of Lotus Notes and Accessibility Program mail users in 2009 has increased by 6% over that of 2008. 98% of staff are provided with mail accounts for internal communication by electronic means;
- ➤ The number of contract staff using the e-leave system in 2009 has increased by 2% over that of 2008.



二○○九年的工作成效 ACHIEVEMENTS IN 2009

2) 節約能源

- 員工對於報告"冷點"的意識提高,於需要時會要求保養維修人員協助調節冷氣設備:
- ▶ 員工於離開辦公室前已關掉所有電器及電燈;
- 於更換光管時選用輕巧節能的 光管以節省能源;
- 於 2009 年,為 22 台影印機/ 飲水機安裝時間掣,並設定於 非辦公時間內關掉電源。

3) 資源回收及循環再用

- 於 2009 年回收可供循環再造的紙張重量為 16 464 公斤;較 2008 年增加約 34%:
- 於 2009 年使用可回收打印機 或 傳 真 機 碳 粉 盒 的 數 量 為 1007 個 ; 較 2008 年增加約 18% ;
- 再造紙的使用量於 2009 年提高了 3%;
- ▶ 循環使用所有節日裝飾品。

2) Energy Saving

- Staff are aware of the procedure of reporting "Cold spots". Assistance from the maintenance staff will be sought to adjust the air-conditioning system when necessary;
- Staff have switched off all electrical equipment and lightings before leaving the office;
- Compact fluorescent tubes are used for replacement to economise power consumption;
- Timers have been installed on 22 photocopiers / water dispensers in 2009 to switch power off during non-office hours.

3) Reuse and Recycle of Resources

- 16 464 Kg of waste paper was collected for recycling in 2009, representing an increase of 34% against 2008;
- 1007 pcs of toner cartridges for laser printers and fax machines was consumed in 2009, representing an increase of 18% against 2008;
- Use of recycled paper has raised by 3% in 2009;
- All decorative accessories for festival decorations were reused.

4) <u>減少污染及營造一個綠化的工</u> 作環境

- 於 2009 年,本處多栽種了 10% 的盆栽以美化工作環境:
- ▶ 有 67 位員工參與 2009 年的 「公益綠『識』日」;
- 外勤員工需要外出工作時,已 盡量使用公共交通工具代替部 門車輛。

4) Minimisation of Pollution and Establishment of a Green Workplace

- The number of potted plants has increased by 10% in 2009 for beautifying our working environment;
- ▶ 67 staff have participated in the "Community Chest Green Day" in 2009;
- Staff have used public transport instead of the departmental car when performing outside duties.



二○一○年的環保目標 ENVIRONMENTAL OBJECTIVES FOR 2010

學生資助辦事處仍會繼續堅守環保責任,並加強灌輸環保意識給員工。為了持續進步,我們的 2010年環保目標包括:

- 繼續研究使用電子申請表格;
- 計劃將現時的電子處理假期申請系統的應用擴展至所有合約員工;
- 繼續節約用電,確切執行節約 能源的措施:
- 減少製造廢物及預期整體廢物 回收增加10%;
- 鼓勵員工於會議時減少使用樽 裝飲品;
- 增加綠色空間及預計增加 10% 的盆栽;
- 繼續鼓勵員工參與環保工作及 活動;
- 繼續研究切合工作情況的適當 措施,以達至『清新空氣約章』 的要求。

This Agency will continue to shoulder its environmental responsibility and strengthen the environmental awareness of our staff. To strive for continuous enhancements, our environmental objectives for 2010 include:

- Continue to explore the use of electronic application forms;
- Plan to extend the coverage of the existing e-leave system to all contract staff;
- Continue to economise electricity consumption by close adherence to the energy saving measures;
- Minimise waste production and increase the overall collection of wastes for recycling by 10%;
- Encourage our staff to reduce the consumption of bottled beverages at meetings;
- Enhance green workplace by increasing the number of potted plants by 10%;
- Continue to encourage our staff to participate in environmental protection practices and activities;
- Continue to explore appropriate measures specific to the nature of our operation to fulfil the commitments of the "Clean Air Charter".
